

**NOTICE OF CONFIRMATION OF DEFINITIVE MAP AND STATEMENT
MODIFICATION ORDER**

(PUBLIC FOOTPATH (MIDDLESBROUGH) NO.65) DEFINITIVE MAP AND
STATEMENT MODIFICATION ORDER 2023**

The above named Order made on 30th January 2023, under Section 53 of the Wildlife and Countryside Act 1981 was confirmed without modification by the Council of the Borough of Middlesbrough on 26th May 2023.

The effect of the Order, is to modify the definitive map and statement by adding to them the footpath as described in the schedule below.

A copy of the confirmed Order and the Order map have been placed and may be seen free of charge at the Town Hall, Middlesbrough from 9.00 a.m. to 4.30 p.m. on weekdays (excluding Bank Holidays). Copies of the Order and map may be bought there free of charge.

This Order took effect on the day it was confirmed but if any person aggrieved by the Order desires to question its validity or that of any provision contained in it on the ground that it is not within the powers of the above Act, or on the ground that any requirement of that Act or any regulation made under it has not been complied with in relation to the Order, he or she may apply to the High Court for any of these purposes under paragraph 12 of Schedule 15 of the Act within 42 days from 26th May 2023.

SCHEDULE

Description of path or way to be added

Public Footpath commencing at its junction with Middlesbrough (Footpath) No. 50 at Grid Ref NZ 53951 / 13459 (Point 'A' on the Order Map) and proceeding in a generally south-westerly direction for approximately 100 metres across a field to Grid Ref NZ 53941 / 13362 (Point 'B' on the Order Map) where it then proceeds in a westerly direction for approximately 40 metres to a stile at Grid Ref. NZ 53905 / 13344 (Point 'C' on the Order Map). The path then proceeds in a generally westerly direction keeping a fence line on the left and skirting around a coppice for approximately 306 metres to Grid Ref NZ 53615 / 13303 (Point 'D' on the Order Map).

The footpath then proceeds in a north-westerly direction across a field for approximately 103 metres to the start of the grassed track and fence line at Grid Ref

NZ 53527 / 13354 (Point 'E' on the Order Map). The path then proceeds in a generally north then north easterly direction along a track which is surfaced in places, following a fence line on the left for approximately 82 metres to Grid Ref NZ 53558 / 13415 (Point 'F' on the Order Map) just before the pumping station.

The footpath then proceeds in a generally north westerly direction through a gate at Grid Ref NZ 53273 / 13593 (Point 'G' on the Order Map) before continuing along a well-defined route through the woodlands for approximately 240 metres to the start of a board walk at Grid Ref NZ 53370 / 13524 (Point 'H' on the Order Map). The path crosses the board walk which runs through the centre of a hedge circle then continues north-westerly still on a well-defined route for approximately 120 metres to a gate and its junction with Middlesbrough (Bridleway) No. 47 at Grid Ref NZ 53288 / 13597 (Point 'I' on the Order Map).
